ARCHITECTURAL CONTROL COMMITTEE

Since the last Board meeting, the ACC has approved requests for 1 re-shingle, 1 shed, 1 landscape + deck, 1 solar panels, and 2 window and front door replacement. Violation letters have been sent for 2 vehicles, 11 repaints, 7 holiday lights.

MAINTENANCE COMMITTEE

- Rita Prokopiak noted she has asked Sembrar for a proposal to repair the landscape on top of the rock wall behind the tennis courts.
- Rita Prokopiak reported that she will obtain proposals to plant several large evergreen trees this 2. spring to replace the ones that died of pine beetle infestation. She also noted that two irrigation backflow devices were recently stolen. Sembrar has recommended that they remove the remaining devices until spring. The Board concurred with this recommendation.
